Dear Orchestra-Youth Parent or Guardian:

Welcome to another exciting year of the Reading Youth Symphony Orchestra. No doubt our musicians will be hard at work honing their skills to produce the exceptional performances that we have come to expect.

In an effort to support our musicians while keeping the cost of the program to a minimum, a volunteer rotation roster has been produced. As you can see, the roster requires each family to provide a volunteer only one morning per season – a total time contribution of 4 hours. Participation is **mandatory**, and each parent must contribute the following:

1. Arrive at 8:30 a.m. to supervise the setup of chairs for both orchestras
2. Provide a minimum of 27 individual drinks (bottles of water, juice boxes, etc.)
3. Provide a minimum of 27 small, individually packaged snacks (no large/shared bags, etc).
4. Setup and oversee the distribution of snacks to the musicians
5. Cleanup after snack break
6. Oversee the return of chairs to the chair dollies at the conclusion of rehearsal as per direction of the conductors. See Rehearsal Setup Directions

If you are unable to participate on your assigned date, it will be your responsibility to coordinate a date trade with another family on the list. Phone numbers and email addresses have been provided for this purpose. Thank you for your participation in the program

Rehearsal Setup Policy

Parents who are scheduled to provide snacks must supervise the rehearsal setups. Scholarship recipients must check in with the parents ½ hour before rehearsal begins and set up chairs and music stands per attached seating layouts. At locations other than Exeter Senior High School or when the rehearsals have to be done on a stage, it may be possible that the complete layout would require setup.

After rehearsal, the locations have to be returned to the original setting and chairs and stands need to be stored away as required.

The tuition reduction is a work scholarship. The reduction will be paid back at the end of the 2009-2010 season according to rehearsal setup attendance. If a setup team member is unable to attend, it is his/ her responsibility to switch with another team member and notify the Rehearsal setup coordinator at least one day before the rehearsal or a deduction from the payout will occur.

The supervising parents need to report absents of setup team students to the Rehearsal setup coordinator for the same reason.

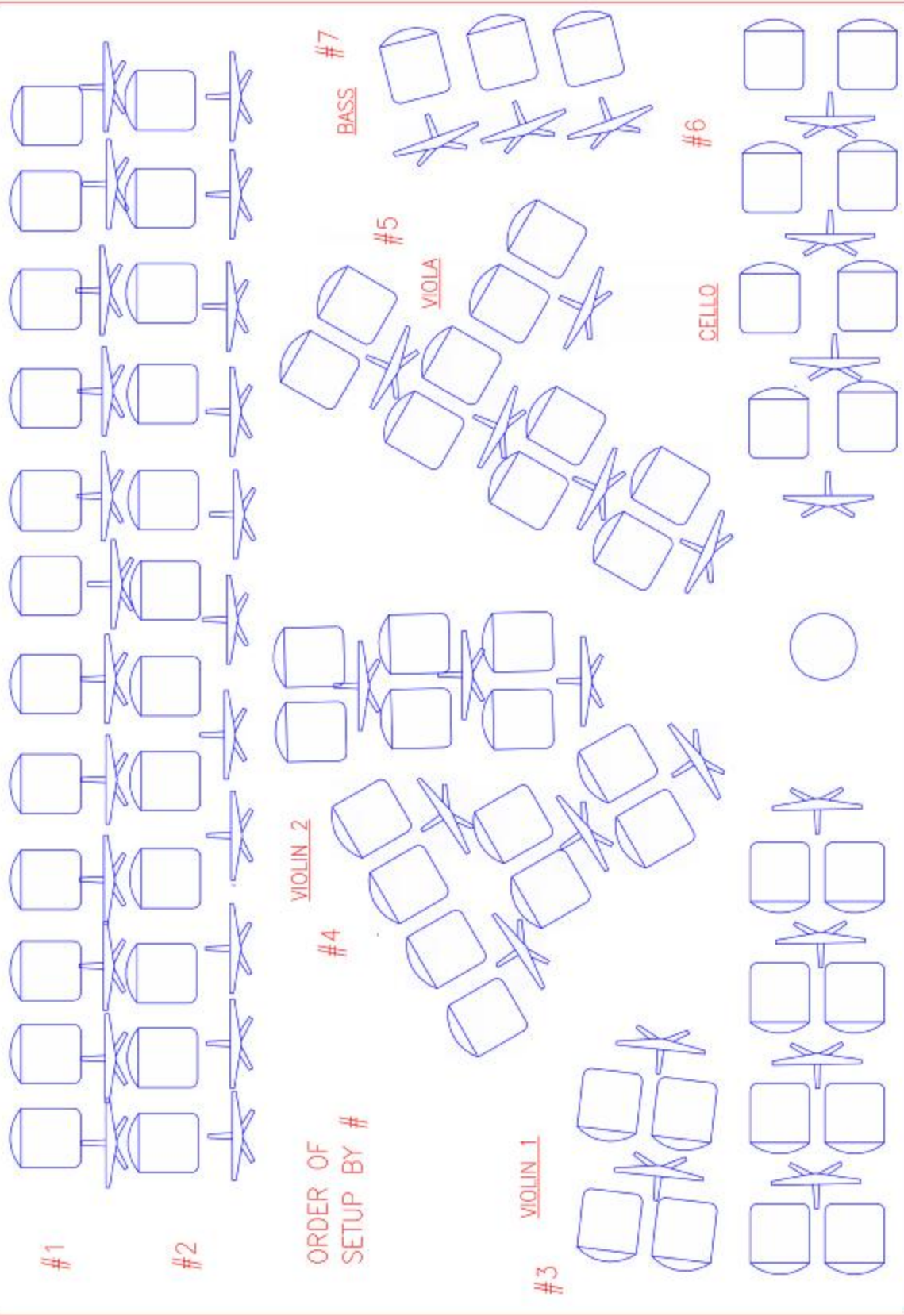
